



Fall 2008 Olney Artist Market Guidelines

Guidelines For Entry: Artists must be juried to participate in the Olney Artist Market and have a working email address.

Application Deadlines: Friday, March 21, 2008 (Start Date for the Market is May 4th, 2008) Once juried into the Artist Market, artists may participate for the remainder of the season and need not re-apply until the next season. Entries should be received by email or in person.

Applications for Entry Must Include:

- . Vendor form (either mail or download from website olneyfarmersmarket.org, filled out and signed
- . Samples of work should only be submitted if they are small, easily transported and not breakable. Otherwise quality images are preferred, either printed or on a CD (please save all images on jpegs).
- . An image or drawing and detailed description of the proposed display.

Criteria for Selection:

- . Preference given to unique, hand-crafted artwork or uncommon medium in the context of an open-air market. Please do not submit pre-fabricated, commercially purchased work.
- . Preference given to creatively designed display booths (display booth area no larger than 10x10) While the artwork is very important, the overall creative atmosphere and appearance of the market is even more so. Suggestions to diversify display include: varied heights of display elements, creative re-use of architectural pieces, such as doors and windows, wooden crates, bright colors, etc.
- . Professionalism of application for entry, including samples/images of artwork and display proposal.

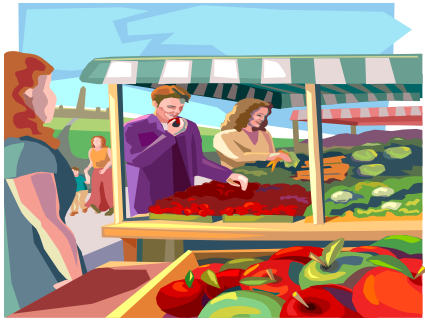
General Information:

The first Artist Market of the 2008 season will be Sunday, May 4th.

Cost: \$20 per Sunday plus \$10, if set-up help required

Checks and Cash only. Checks made payable to *Olney Farmers Market, Inc.*
Maryland Sales Tax laws must be followed

Sign up Schedule: Upon acceptance, you will receive a sign-up sheet for the entire season, May 4th – November 9th. If you sign up and pre-pay for more than 16 days at one time, you get one day free! If you sign up for all of the Sundays, you get two days free. NO REFUNDS WILL BE ISSUED DUE TO RAIN.



Spring 2008 Olney Artist Market Guidelines

The Artist grants the Market permission to use information and photos that the Artist has submitted, and any photos taken while exhibiting at the Market, in ads, print and web-based guides distributed to the public for the purpose of promoting both the Market and Artist.

Rules of Ethics:

(Issues concerning conduct will be addressed by the Market Manager)

1. Artists shall conduct themselves in a professional manner while selling.
2. Artist agrees to sell during the entire duration of the market day, unless the Market closes due to holidays or bad weather.
3. Artist is only allowed to sell items formally approved by the Market Manager or review committee.
4. Artist must comply w/ all federal, state and local regulations.
5. Artist will confine all material to assigned space.
6. Artist will not approach a customer viewing another artist's display.
7. Artist will not use profanity or become physically abusive.
8. Artist is responsible for behavior of family and friends.
9. Artist may not 'hawk' their wares (in an aggressive manner).
10. Artists whose products (scents and sounds) may have an impact beyond confines of booth must be sensitive to impact on others.
11. No pets will be allowed.

Termination:

The Market has the right to terminate the agreement, should the Artist violate any of the rules. The Agreement may be terminated at any time by either party. All terms and conditions shall survive termination. In the event of termination, absolutely no refunds will be given.
